Wedge and overlay Kampen Rd., from WIBU Rd. to Cty. Hwy I. The town will also partner with Lowville and Leeds, to wedge and overlay parts of Goosepond Rd. per approval from other municipalities. Treasurers update on the banking accounts, and taxes collected. Dorothy & Dan Richards came for the discussion of the Comprehensive Plan updates. They were interested in how the process would go.
