Board Meeting Minutes
March 9, 2022, at 7pm

Chair Moll called the meeting to order at 7:00pm with all board members present.

Clerk Struck read the minutes of the February 9, 2022, Board meeting. MSC Manke/Klahn approved the minutes as read.

Dan Richter provided a PowerPoint presentation for the new Lodi School Referendum. The presentation is also available on the school district website.

MSC Klahn/Manke motion to approve the of request from Jake Collins & Natia Schoepp to create a two-lot Certified Survey Map for tax parcel 616 currently zoned A-1 Agriculture with a site address of County Hwy K, Arlington, WI 53911. The CSM proposes to create a new 5-acre Lot 1 to be rezoned RR-1 Rural Residence to allow for the construction of a single-family residence with Lot 2 consisting of 30 acres to remain zoned A-1 Agriculture but with an A-4 Agricultural Overlay applied to restrict any additional single-family development on the 40 acres.

Bipartisan Infrastructure Law. Program resurfacing or reconstruction for roads, Smokey Hollow County K to Meek Road, Hwy 60 to County K on WIBU needs resurfacing. We could use the ATC funds to use for the towns portion of the construction. MSC Klahn/ Manke approve to move forward would with the BIL project. Chairman Moll to look at estimates for the Smokey Hollow County K to Meek Road, Hwy 60 to County K on WIBU resurfacing.

MSC Klahn/Manke motion to approve the Solar Ordinance Title 17 Chapter 1 as it is written.

MSC Manke/Klahn to appoint Nate Moll in charge of road maintenance.
